## BIAS INCIDENT SEMESTER REPORT - Fall 2019

This log is a summary of reported incidents to the Bias Response Coordinator (BRC) from September 2019 through January 2020. Incidents summarized on this log are situations where reported harm has been caused in the campus community and may, in some cases, include legally protected speech. The BRC works to respond within 48 hours to harmed parties, makes appropriate referrals to campus processes/resources, and coordinates proactive and restorative education with involved parties.
